



# Ohio Work Ready Grant Application for Non-Credit Programs through Workforce & Community Services OFFICE OF FINANCIAL AID

## About This Form

---

The Ohio Work Ready Grant is for Ohio residents enrolled in an eligible program that leads to an industry-recognized credential, certificate, or degree and prepares the student for an in-demand job.

### Eligibility requirements

To be eligible for the scholarship, you must meet the following criteria:

- Submit an **Ohio Work Ready Grant application** and be selected as a recipient.
- Be an **Ohio resident**.
- Be registered for **Selective Service** if required to register by law.
- Be enrolled in one of the **eligible programs** listed on this application.
  - Complete the Free Application for Federal Student Aid (FAFSA<sup>®</sup>) and receive a Student Aid Index (SAI) of 3750 or less.
    - *If a student is selected for verification and the determination is made that the student is no longer eligible for Ohio Work Ready Grant due to verification results, any Ohio Work Ready Grant funds applied to the student's account for that academic year will be removed from the student's aid package.*
- **Complete courses successfully** to continue eligibility.

### Awards

- **Up to \$2,000** can be awarded to part time degree seeking students or students seeking a short-term certificate or industry-recognized credential.
- A student who completes multiple short-term certificates or industry-recognized credential programs in an academic year is eligible to receive up to \$3,000 for the year, regardless of the number of programs completed in the academic year.
- Awards from the Ohio Work Ready Grant can be used for tuition and fees.
- Funding is limited and only available through **June 30, 2025**.
